

## **Board's statement regarding proposed dividend for 2012 Annual General Meeting**

The Board of Holmen AB has proposed that the 2012 Annual General Meeting resolves in favour of paying a dividend of SEK 8 per share, a total of SEK 672 million, which is an increase of SEK 1 per share to the previous year. The proposal complies with the Board's policy, in that decisions on dividend are to be based on an appraisal of the Group's profitability, future investment plans and financial position.

The proposed dividend corresponds to 17 per cent of profit for 2011 and means that 3.4 per cent of equity in the Group at 31 December 2011 will be paid out by way of dividend.

The Board has established that the Group shall have a strong financial position with a debt/equity ratio - defined as net financial debt in relation to equity - in the interval between 0.3 and 0.8. The debt/equity ratio on 31 December 2011 was 0.32. Payment of the proposed dividend would raise the debt/equity ratio by around 0.05.

Holmen AB's equity at 31 December 2011 amounted to SEK 11 153 million, of which non-restricted equity was SEK 5 238 million. Assets and liabilities measured at fair value according to Chapter 4 Section 14a of the Swedish Annual Accounts Act had an impact of SEK 31 million on equity. The Group's equity at 31 December 2011 amounted to SEK 19 773 million. Complying with IFRS, no distinction is made at Group level between restricted and non-restricted equity.

The Board considers that payment of a dividend of the amount proposed is justifiable in view of the demands made on the company and the Group by the nature, extent and risks associated with the business in terms of the amount of equity required, and taking into account the need for consolidation, liquidity and financial position in other respects. The financial position will remain strong after payment of the proposed dividend and is considered to be fully adequate to enable the company to fulfil its obligations in both the short and the long term, as well as to finance such investments as may be necessary.
